Enclosed is the information on this year's State Plumbing Apprenticeship Contest. It will be held at Serve-Pro of North Prince William County Training Facility, located at 11430 Bells Ford Road, Manassas, Virginia 20109 on Wednesday April 14th, 2010 as part of the 2010 PMPV/VAPHCC/State Spring Board Meeting.

The contest starts at 7:00 a.m. on Wednesday morning, April 14th, 2010. The contestants should be there onsite and ready at 6:30 a.m. for instructions. This is a "One Day" only contest. If you are late, you will not be given extra time, but you should have plenty of time to finish. We will present the 1st, 2nd, and 3rd place awards that night at the Northern Virginia's monthly dinner meeting.

The apprentice's will be required to rough-in a half bathroom on a pre-built module and the materials will be provided. Contestants will be given a layout and specification sheets, as well as the needed materials to compete in the contest. You will not have to drill any holes, and contestants will have approximately 7 hours to complete the contest. 1st, 2nd, and 3rd place plaques are being awarded for being the best, not for finishing first, we are looking for quality not quantity. Contestants must provide their own tools, and a tool list is attached for your convenience. We will send the 1st place winner to the PHCC National Competition in Las Vegas, Nevada in October.
